Motion Text: That the Assembly approves the Bylaws revisions as printed in the October 2008 Assembly issue of the 12 Stepper mailed to GRs in August 2008.

- **Explanation:** The Bylaws required revisions as the result of several motions passed by various assemblies and changes to the WSO bylaws. The Bylaws have been checked against the current revision of the Nolo Press version on nonprofit bylaws since 1989. The Bylaws committee made several changes to reflect the current version of the Nolo Press document.
- **Discussion:** See Bylaw Committee Report:

Motion #0810.06 (Passed substantial unanimity):

Motion Text: That the NCWSA Bylaws Committee be responsible for the correcting spelling, punctuation, grammatical errors, labels and renumbering articles and subdivisions within articles, of the NCWSA Bylaws, as appropriate, without further review and approval by NCWSA prior to printing and distribution of the Bylaws.

- **Explanation:** After identifying types of change that are considered housekeeping, such as commas, misspellings, rewording of sentences to make them clear, it is not necessary for the Assembly to bring such items to the mike. Instead, they may bring them to the attention of the Bylaws coordinator and committee members. (The language is similar to that used in motions 9509.17 and 9507.18)
- **Discussion:** See Bylaw Committee Report.

Motion #0810.07 (Failed by 2/3 majority) Note: this motion was tabled from 09/16/2007 Assembly

Motion Text: Matter under consideration: NCWSA Guidelines Change:

Text: That the NCWSA change our guidelines so that AI-Anon/Alateen members who are also AA members may be in service beyond the group level, including Group Representative to Assembly, except for positions that "could lead to membership in the World Service Conference (WSC)", such as District Representative. (Quote from pg 70 of Service Manual 2004-2007.)

- **Explanation/History:** A similar motion to this has come before this body many times and gone back to the groups for discussion and come forward again. In the past the motions have been for our Delegate to take to WSC a recommendation that members of AI-Anon who are also members of AA be allowed to serve above the group level. This is not the same motion. Before we ask WSC to make any changes, this motion speaks to Let it Begin with Us. Let us consider making changes at our level.
- **Discussion:**
 - Request to withdraw part that says "except for positions that could lead to membership in the WSC". Response: I understand your request. But since this is the way this motion was noticed, we need to have a chance to discuss it as noticed to the groups.
 - We can all sit here and say these positions will not lead to delegate, but someone can always move out of state and say oh yeah I have been a GR or DR. There is no way to check that. This has been talked about for over 20 years. You all have had the history last year. I am not sure of the consequences, but if the whole area did this, your Delegate might not be allowed to vote at the WSC meetings.
 - Reference to new Bylaws, page 4 section 4: Eligibility of Members: "A. Any person selected as a GR by a registered AI-Anon Family Group or Alateen Group is eligible for membership in NCWSA. The method of selection is up to the group conscience of the particular group, except that the current policies of the World Service Conference must also be followed". We cannot change the bylaws until after WSC changes the current policy. We have aligned ourselves with

WSC policy, and the policy of the Conference is that Dual members not serve as GR, DR, or any position that affects policy. I think the motion needs to be withdrawn because we cannot pass it.

- I was a member of the 1977 WSC which voted not to allow dual members into our service structure as a GR.... After much discussion. This motion speaks of positions above the group level which do not lead to the WSC. This is our Delegates. The Conference will not seat a dual member delegate. According to our own Service Manual, which we use, all positions beyond the group level may lead to the WSC. . We know there are 3 levels of service, the group, district and area. A GR is eligible, to become DR, a DR is eligible to become an Officer or a Delegate, according to our Service Manual. We are a separate entity according to Tradition 6. We always cooperate with AA. At the 1977 WSC, Lois shared with us that when she asked permission from Alcoholics Anonymous to adopt their 12 Steps, AA said yes. But with the stipulation that we would be a completely separate society, and NOT a subsidiary of AA. See page 176 *Lois Remembers*.
- I have tremendous respect for the history of this organization and the people who went before us. But this is a dynamic that changes over time. Reality is a lot of our members are dual members. I would like to also address the idea that members here going to another group and not saying they are a dual member. That is doubting their ability to tell the truth. We request them to leave their other 12 affiliations at the door. We are separate organizations, yet we ask them to break their anonymity in this particular case. I think it is a major conflict of interest. I think if it is in the bylaws we may have to remove this motion, but I think we need to bring forward a motion to change the bylaws in this particular case. We are separate entities and we are asking these members to break a tradition of anonymity.
- I remember from my first meeting hearing talk to each other and reason things out, let there be no gossip. Wow that sure was different from where I was from. I served from the beginning in one service area or another. Then we needed a new GR, and I did it, not out of obligation, but because I was grateful and I wanted to. I went to District meetings and then my first assembly. They stated the Dual Member restrictions and I turned to my sponsor and said what? My sponsor said yes, if you are a Dual member, you can't vote. At break I went out the door and shredded my membership card to AA. I think this policy is wrong. It is very unclear and ambiguous of what a member of AA is. It might have made a lot of sense back in the day when Bill W said keep us drunks out of it. But that was 70 years ago.
- I would like to point out that as this is written it would have to be changed as it is a bylaw change not a guideline change. As it is written it could not be passed. Response 1: This motion as written was in order the way the Bylaws were written before they were changed yesterday. Response 2: That is not accurate. This was in the Bylaws previously; we just moved it from Section 4 letter B to Section 4 letter A. If the assembly decides to go forward with this it would require a Bylaws change.
- I do not think we are prepared nor have the information to vote. Let me start with anonymity. I do not want to know if you are a dual member. It is none of my business, and it does exclude people. Autonomy, each group can be autonyms, and can decide what they want to do, so please do not tell me what to do. Please talk to people you know, it is not black and white. We have checks and balances. We will not vote you in if we don't like you. Through our vote we have power.
- Our District does allow group members above group level. I was surprised to find we were not in line with WSC. Maybe those who really want to change this at the area are trying to force solutions and you need to think maybe taking Al-Anon as it is and if you want to change go through the proper channels. I suggest keeping our side of the street clean.
- I have felt passionate about this subject. I know a lot of dual members that I have a lot of respect for as well as respect for the Traditions and how they came about. In 1977 it was important to keep it the way it is. But I also believe it needs to be dynamic. I believe we need to look at our control issues around this. One of the comments from my group was as a member of AA and Al-Anon, AA permits me to serve above group level. Another thing is women did not have the right to vote until 1920, and we didn't say for 120 years our country was based on male vote lets not change it because it's been that way.
- This motion allows Dual members to vote as GR at Assembly. It specifically states these members from becoming DRs. Because we cannot change this motion and vote today if changed, I suggest if passed we make a motion to change the Bylaws.
- The way this is worded it cannot be approve. I would like to see this withdrawn and a committee of people formed who would like to work within our current policy to create a balance, an opportunity for Dual Members to work within NCWSA. That is how we work to make change. We work within the current policy to expand it, not try to change the policy altogether, work in small steps.
- Bylaws Page 2 Section 3 states #B states: In the conduct of its business NCWSA shall refer for guidance to the California Nonprofit.....and to literature, memoranda, procedural manuals and guidelines published by the WSO. As a result of my groups discussion it became clear to me that I want to stay a part of World Wide fellowship of Al-Anon and we need to follow their guidelines.
- It appears to me based on previous information we cannot vote on this because it is in direct conflict with our Bylaws. It appears to me Jackie that we have only one alternative to have this motion withdrawn. Response: I am not interested in withdrawing this motion as many people asked it be made. You can vote either yes or no or vote later.
- This discussion seems to becoming a rehash of the discussion we had last year, instead of addressing this motion. I would appreciate discussion on this motion only and not the history.
- We allegedly practice the principle that we are all equal in Al-Anon. It seems we are considering some members more equal than others if we don't allow Al-Anon members who happen to be members of AA to serve above group level.

- A Dual Member states “I have no interest in any of this because my job in life is to control my disease and it is all I can do to do that. I love AA I love Al-Anon but I would not take a spot.” Two weeks later after 13years he fell off the wagon. “Bill W. was right in the first place.
- I would like a perfect world where everyone read the Service Manual and policy regarding this, because we don’t have to ask somebody to break their anonymity because they would read it, see what the policy was, and never volunteer to do anything above the group level. I feel Alcoholics have to pay attention to their primary program or they will relapse, go insane or die. That is number one.
- Tradition Four states: Each group should be autonomous except in matters affecting another group, Al-Anon or AA as a whole.

Motion #0810.08 (Tabled until Spring Assembly)

Moved: Stephen R.

Seconded: John B.

Motion Text: Delete the words “except that the current policies of the World Service Conference must also be followed” from Article III Section 4 paragraph A of the NCWSA Bylaws.

- **Explanation:** In light of notification requirements for Bylaw changes, I ask that this motion be tabled until the Spring 2009 Assembly.
- **Discussion:**
 - Peggy Bylaw Coordinator: That would not resolve the issue as far as the Bylaws: Article II Section 3 paragraph B there is an additional reference that guides us to WSO also. Response: This statement refers to guidance not a requirement, and I do not see it as a conflict. I think we can use this for guidance but not rule.
 - We would need to eliminate Section 3 completely because it states in paragraph A, adherence to Al-Anon Principles; Step, Traditions, Concepts take precedence over Bylaws. If we don’t follow this principle we would be in violation of Tradition Six. So we would say we are not following Traditions. To me it is an issue of people not accepting the group conscience of Al-Anon as a whole. We have to decide at some point I am a minority and I have to accept the results of the majority whether we like it or not. Tradition Six says we are a separate entity from Alcoholics Anonymous, so when an Alcoholics Anonymous member becomes part of our service structure, it ties the two together, and we violate that Sixth Tradition. Response: I feel with this issue there are a number of things that we have contradictory things in our wordings. I think Al-Anon as a whole has a number of contradictory things around this issue. We can quote certain things from Al-Anon to get things one way and then quote other things to support the opposite.

COMMITTEE REPORTS:

Bylaws Committee: Peggy P.

- Committee: Peggy P. Vicki H. Joan W. Jim S. Art B.
- 12 Stepper page after 72. – beginning of the Bylaws draft.
- Two Motions #0810.05 #0810.06 were presented. (see motions section)
- Reminder: The Bylaws are a legal document. They do not contain every requirement or guideline established and followed by our area. They do contain the legally required definitions and procedures. It is to our benefit not to include everything because when we choose to change something, for example the guidelines for our coordinators, or even just listing the coordinator positions, we would have to change the Bylaws. The content of our Bylaws meets the legal requirements of our area for a Non Profit Corporation, but also gives us the flexibility to adapt and change without continuously updating the Bylaws.
- Types of revisions; Addition; Deletions; Housekeeping; Clarification/Correction; Substantial Change; Endnotes. Endnotes were added for explanatory notes not needed in the Bylaws but helped in clarification.
- Johanna proofread end copy and is taking notes today in case there are any additional revisions.

- Post Assembly – after approval the revisions will be incorporated into the Bylaws, reviewed editorially, copies will be distributed to all registered groups in NCWSA. They will be posted to the web and will be available to GRs attending next May Assembly and mailed to GRs not attending that Assembly.
- Reminder: As required by CA State Law for Non Profits: Any revisions to the Bylaws the corporation is required to notify its members (groups) of the changes at least 45 days in advance of the meeting. We use the 12 Stepper for this notification. Any other changes brought to the floor today, will be considered by the Bylaw Committee and would have to be presented at the next Assembly with notification of 45 days in advance.
- Substantial revisions as presented in the Assembly issue of the *12 Stepper* will be reviewed by sections.

Questions:

- What do you mean by housekeeping revisions? Answer: Spelling, grammar, punctuations.
- Page 23 – Preamble why was the language changed in Suggested Alateen Preamble paragraph two ...we cannot change or control our parents? Answer: It was changed to match the current service manual. If they left something out or changed it, we are making ours the same as theirs.
- Page 4, Item B – Term of office for Group Representatives is being stricken. What is the intent behind that? Answer: We do not want to specify that in the Bylaws and give more flexibility to the area. In case the area wants to make changes as well as the groups. We are not going to extend the term beyond three years. We are not defining the term Group Representative; we are allowing the groups to define that. We do not have control over what a group decides. It says here that the GR coincides with the term of office with the NCWSA Delegate and officers. That has been our expectation for the last years. The GRs get elected now and they serve three years with the same term of officers. There has been some discussion with the LRPC to maybe change to one third rotating each year. This couldn't happen without the bylaw change and besides it is none of our business is why we took it out.
- Page 5 Section 2. I thought we were trying the two assemblies on a three year trial basis. If we change it in the Bylaws then the decision to change after three years is out of the assemblies hands you can just do it. Answer: It is the Chairpersons choice to call assemblies as needed. The GRs voted for the second assembly, but it is still the Chairpersons responsibility to call assemblies. This was not added it has been there it was part of the deleted paragraph also. If in three years the Assembly votes to continue with the second assembly it would not need to be noted in the Bylaws. The Chair can call as many Assemblies as necessary if there is legitimate business to discuss.
- Peggy and her committee were given a cheer for a great job done in a professional way.
- Page 18 Section 3B. Requirement for Teen Safety, in accordance with the mandate of the WSC and state that they meet this requirement on all flyer and announcements... Does this mean when we encourage Alateen participation there is a lot to put on a flyer and do we have to put this statement, as I am not sure this on a flyer provides any additional safety for our teens. Answer: This is in the Bylaws and a requirement for NoCAC. It is a requirement that any flyer that includes Alateen have that on the flyer. Clarification from Jim S.; Any flyer (including AA Conventions) posted on the Web site requires that statement on them. In your District or Groups it is required, but there is no way to regulate that. Guideline B17 has the statement. More questions regarding the Alateen Safety requirements were brought to the mike. As these are not Bylaw questions Peggy referred them to Jackie to place on the agenda for a later time.
- Page 24 Tradition changes: seems since there are changes, it is somewhat flexible. Answer: These changes were made to match the Service Manual. Comment from Sandi C. At some point a long time ago some editor at WSO changed these two things. WSC was not aware of the changes and then when some other research it was discovered that unknowingly somewhere in history these had been changed. These are housekeeping to go back to correct verbiage.

Discussion:

- Peggy presented another question for the Assembly: Would this Assembly want the committee to investigate changing the By-Laws to require two-thirds (2/3) majority on all votes which supports a substantial unanimity as stated in the Service Manual? The bylaws would not be revised now; it would be taken back to committee for review and brought to the Assembly for consideration the next time the bylaws are revised. A Majority is defined in the By-Laws in endnote number 14 as a simple majority (50% +1/2 person). Delegate Alternate Delegate and Chairperson require a 2/3 majority.
- It makes a lot of sense that if we had 2/3 majority on each candidate, it shows a lot of support, whereas 50% you could have 49% really not happy. In Al-Anon we recognize a group conscience and a simple majority is not a substantial group conscience. I suggest we change the election votes required to 2/3 for Delegate and Officers, not general voting.
- Is substantial unanimity = 2/3 vote? Answer: I do not know if it is defined anywhere but 2/3 is a lot closer than simple majority.
- Why are we discussing this without a motion? Answer. We are doing Knowledge Based Decision Making. The idea is discussion first to see how far along we are and get a sense of what this group wants before we make a motion.
- The spirit of Al-Anon, the spirit of substantial unanimity, is sported by 2/3 vote on any thing we do. If it gets down to counting 1/2 persons, I would not feel comfortable of either side of the vote.
- Reminder: the Bylaws are a legal document and Incorporation Laws of the State of California require 50% majority. Why impose on the Assembly anything greater than this requirement. In the Bylaws on Page 28 endnote

14 last sentence “The members may by a 2/3 majority choose to use a 2/3 Majority for particular items brought to the Assembly.” It is also stated in the Service Manual on page 136.

- Once again this is not written in the Bylaws because we want to keep the Bylaws as simple as possible and state only what is needed for the Non Profit status, but the endnotes are used for clarification and flexibility.
- Warranty 3 states: that all decisions be reached by discussion, vote and whenever possible, by unanimity.
- Page 2 Section 3 #A of the Bylaws states Adherence to AI-Anon Principles: ...In the event any Bylaw conflicts with AI-Anon’s Twelve Steps, Traditions and Concepts, application of the Steps, Traditions and Concepts shall take precedence over adherence to the Bylaw. We have this principle of substantial unanimity in our endnotes. There is a difference between what is legal and what our principles are.
- I keep thinking about our meetings and how the unanimity holds us. Anytime in a business meeting that we make a decision that is close to 50% vote there is a loss of this sense of being held and there is a sense of dissension that lasts. The 50/50 shows we are not ready to vote yet.

Summary:

- We have determined that this is covered in the Bylaws and endnotes and that the option is available to any member to go to the microphone and request a two-thirds (2/3) vote at any time for a specific motion. The Assembly will discuss that request and vote on whether they want to use a 2/3 majority or stick with a simple majority. That provides the opportunity for anybody to request substantial unanimity. Chairperson may request 2/3 majority for a sensitive issue. We do want an idea of our clear voice and the only way to do that is based on substantial unanimity.

Group Conscience: With a show of hands, by substantial unanimity, the group wants to leave things as they are.

- Peggy stated: I thank the Assembly for the opportunity to discuss this, because several people approached me with concerns about this as well as I had some concerns. I wanted to know and understand what some of the options were, why it is stated the way it is, and where our flexibility is. I think we have provided everyone with exactly that. I would like to close this discussion with the Serenity Prayer.

Executive Committee: Chris A- C. Chairperson:

- Because we are a nonprofit corporation in the State of California we are required to have a Board of Directors. Our EC serves that purpose.
- Members: Claudia M.D10; Patti M.D12; Harlan H.D23; Joe G. D17; Chris A-C.
- Have served the last 12 months with Gratitude.
- Hope to turn over an organized binder to the next EC in Feb.
- We were asked to review the surveys from the May Assembly. After discussion we decided this is outside of the scope of our responsibilities and it did not fit the venue for which it was intended. As a result they will be returned to the Chairperson.
- We interview and support our officers. Provide oversight of officers. We have a new position, AAPP and Lori is the new person in that position. The EC interviewed her and found her to be doing a very good job.
- Approved the financial assistant or the Assembly.
- Rotation of EC duration 18 months during panel we have rotation once during panel. Suggested changing rotation to a three year commitment. LRPC to look into and waiting to hear back. Wondering if we overlap rotation of GRs and DR how that would affect the EC.
- Recommend that EC membership is comprised of past DRs not current DRs. This would decrease the load on current DRs and would add continuity to our panel. We understand this would add an additional expense to our budget, but this would balance out as we have fewer past Delegates currently attending our meetings than we have had in the past.
- Working to have better hand off information to successors.

Budget Committee: John S.

- A budget committee’s responsibility is to meet with Treasurer to complete our audit. This has not happened for various reasons; Nancy has assured me we will meet by the end of the year.

Discussion and Questions

2009 Budget: This discussion was lead by John with questions from the floor:

- See 12 Stepper October Assembly Issue page 23
- A new line item has been added for the Alateen Special Event, Sponsors workshop.
- Investigating Telephone conferencing to eliminate excessive travel reimbursement.
- An Additional line item reflects the cost for second assembly. As this is a new event it will take a couple of years to get an idea of actual cost.
- Question: Do you know what the attendance at the previous spring assembly? Response: GRs 274 + NCWSC approximately 325 total.
- Question: Isn’t it a mathematical process $325 \times \text{Registration fee} = \text{income}$? Response: It is the chairperson responsibility to set the fee based on various factors. That happens after the budget. We could make that assumption may not be valid once the assembly is planned.
- Line 6z, column 2007, the 12 Stepper should read \$9058 to reflect correct Profit and Loss. Items were just posted to wrong account.

- The line item totals are listed in the budget presentation. For example one coordinator may not spend a lot of money and another coordinator can use it. This allows some leeway. The actual budget shows expected income or expenses for each event or position.
- Question: Why do you project the reduction on line 30z coordinator expenses, from 2008 to 2009? Response: Usually the first year of a new panel we raise the budget because incoming coordinators have supply expenses related to a new position. We did not do that this year. We are expecting a reduction in contributions this year because of the economy. We cut expenses where we could. Alateen and Institutions were both high this last year because of very active coordinators with special projects. Also it seems there are some expenses are posted to incorrect line items. Nancy is working with a CPA to correct.

Action to be taken: amendments to Budget:

- Adjust: Line 6z \$12000; line 15z \$2000; line 55z \$12000; line 68z 2000.

COORDINATOR REPORTS

Alateen Coordinator: Chris M.

- Reminder Alateens have Group Representatives too. Encourage attendance at your district meetings.
- Serving Alateen expands my heart and my soul beyond my wildest dreams and it has been a lot of fun to watch and support these young people as they find their own path to recovery and an honor to have them love and support me in my recovery. Chris encourages members to consider Alateen service.
- Created Alateen Sponsors weekend and we celebrated our 2nd year. Last year 50 people attended and this year 60 attended. It was a weekend full of incredible recovery magic. It was an awesome weekend.
- NoCAC’s 30th anniversary is this year. Come to this NoCAC and other Alateen events to support our young people. Remember today’s Alateens are tomorrows Al-Anons. They are our future. Together we can make it, recovering from this disease called Alcoholism.
- Sponsors can sign up for bulletins about events and news at nocal-alateen@yahoogroupd.com. The updated Alateen Safety requirements are also online at ncwsa.org.
- How has Alateen touched your heart? On a table were hearts available with a pin which members were encouraged to share on a heart how Alateens have touched their hearts. The completed heart display will be taken to NoCAC.
- Next year the Sponsors weekend will be in September.
- I participated in a conference call with other Alateen Coordinators from the US and Canada. Great Ideas and lots of energy. The Alateen Sponsor Training Modules was discussed: We would like feed back as this will be used for workshops and training and education District coordinators can check it out once it is finalized. A power point presentation was put together to help train Alateen Sponsors. There are four modules: Overview of Alateen Service (seen today); Second one is geared towards the Alateen meeting; Third module is Alateen Events; Fourth Module is Alateen Challenges. The first of the modules was presented.

Discussion and Questions:

- Reminder we have Alateens in Juvenile Halls and there is the additional step for Sponsors to be certified by the facility also. Schools will also require an additional background check.
- How do you determine who is not mentally qualified? We rely on our local District Safety Persons, Coordinators and District Reps. to do an interview with the perspective candidates, to see who they are, know they go to meetings, know they have a home group, know they are working their program. Even if they get that far in the teens still decide if they want that person as their sponsor. They are very sharp and intuitive.
- New Communication ideas: Area Sponsor conference calls, maybe quarterly. This idea will be passed onto the next coordinator. Not sure of cost or if feasible.

Archives Coordinator: Irma C. (Me Ma Uma)

- Thank you for looking at the Archives table and taking the duplicate copies.
- Thank you for taking the Archives starter kits. Great to see interest.
- It was great seeing you look through the Sweet 16 panel. That was my panel.
- We now have 32 boxes filled with archival material. I expect two or three more boxes then I will be caught up.
- A group in Susanville wanted to know when their group was registered. I found it was registered with WSO in 1973, but it had no WSO number. This prompted me to write WSO Archives to find out when groups were issued a group number. It was 1983.
- Our archives show the service and recovery paths we have followed with interesting happenings, growth and progress.
- We have a section labeled controversies that is only available to current and past delegates.

An 'Irma' story told by Art B.

- When I was asked to write the History of Al-Anon in Northern California the Journey to Recovery, Irma coauthored it with me because she had the archives and I had some words. I would send her a note and say, Irma I am trying to find out about this or that. She would send me an email back saying, 'I'm very very busy, I don't know when I can look.' And at two in the afternoon I would get the answer. Over and over and over again. Irma was elected Delegate of this assembly 33 years ago.

Bylaws and Insurance Coordinator: Peggy P. The report for Bylaws and Insurance was delivered in two parts

Bylaws and Guidelines:

- Guidelines working to NCWSC to identify a better method for updating the guidelines and keeping the Committee members' binders current that will take advantage of web-based updates. Each committee member is supposed to have a binder that has all the guidelines and forms in it that the Area follows. Many of the guidelines have not been updated for years. The new Bylaws and Insurance Coordinator will have the opportunity to aid NCWSC with these updates. I look forward to participating and helping with that effort.

Insurance:

- Working with broker to establish insurance and because of various problems there has been many delays which have affected certificates being issued to our groups. We are close to resolution and certificates of insurance to groups requesting them should be available by the end of October 2008. If your group has requested a certificate over the last 4-5 months contact Peggy to confirm the certificate is still needed.
- Will be able continue to offer to groups just taking time to get there.

Diversity: Pleas S.

- No report prepared.
- Apologized for not being the Diversity Coordinator he wanted to be.

Facilities Coordinator: Gene H. (better known as Fatalities Coordinator)

- Main part of job is getting facilities and making sure all your needs are met.
- Stand for this office if you would like to accelerate your recovery.
- February 2009 committee meeting in Santa Rosa contract signed.
- Convention in Santa Clara contract signed.
- Would like to revise selection process of facilities.
- Presently DRs from section hosting event brings a bid to committee meetings to be voted on. This is a difficult process. I am willing to work with the next coordinator to improve this process.
- Suggest setting up a committee which represents the geographic diversity we have to make selections for locations. This is becoming more difficult because of our size and cost to do this with less than a years notice to find suitable locations.

Group Records: Debbie O.

- Updates are current
- I would like to thank groups in my area for helping with the voting cards the last three years.
- As of October 14, 2008, 759 groups are registered in our area. That is up 31 overall. Hospital and Institutions has 20 meetings; 49 Spanish Speaking meetings (up by 4); 22 men's meeting; 19 women's meetings.
- Any reports or updates that have to do with an Alateen meeting must be approved by the Alateen Area Process Person (AAPP) and then they will be forwarded to Group Records to update the data base from WSO.
- Remember Concept 4 states Participation is the Key to Harmony.

Institutions: Louise M.

- As a member of the State of California Correctional Facilities 12 Step Advisory Board I spoke to a meeting full of Community Partnership Managers (those at the prisons who manage outside groups to into the prisons) to tell them about Al-Anon. After the board members talked about their specific groups, the managers had an opportunity to ask questions of us individually. Several people approached me and I have had a chance to deliver more literature to San Quentin. (The inmates descended upon the literature and gobbled them up. It was requested I send more).
- Literature has also been delivered to Chowchilla State Prison for Women; Deuel Correctional Facility; several of the Friends Outside Organization which distributes literature to county, city and state facilities.
- Still opportunities to go to Solano and a few other places.
- Delivered 2 boxes of literature to Soledad because the manager stated there are two facilities in that compound. After a discussion with the manager he stated they have an early release program that he could probably fit us in there.
- AA H&I conference with Al-Anon participation will be held in Galt at Littleton Civic Center, May 29, 30, 31, 2009. Watch for flyer. Participation is about 700-1000. There will be an Al-Anon panel of professional people in institutions and hospitals, Al-Anon volunteers speaking of their experience, plus the many panels of AA. I (Louise) will be the main speaker.
- Thank you NCWSA for granting me money to buy literature for various institutions.
- Literature goes to Elmwood county institution and Juvenile Hall.
